He is co-editor of the online journal *Social Medicine* and coordinates the social medicine curriculum at the Montefiore Residency Program in Social Medicine.

In 2012, Transaction Books published a second edition of her classic book *The Rise of Professionalism: Monopolies of Competence and Sheltered Markets*, with a new introduction by the author. Her 1994 book, *Behind the Postmodern Façade: Architectural Change in Late Twentieth Century America*, received the Sociology of Culture book award from the American Sociological Association's section, and a citation for excellence from the international book awards program of the American Institute of Architects. She is active in her discipline and an editor of several scholarly journals, as well as a citizen activist in her city, Philadelphia.

**Michael B. McNally**, Ph.D, is an assistant professor in the School of Library and Information Science at the University of Alberta. His research interests include

intellectual property and its alternatives, information and telecommunication policy, digital labor and theories of the information society. He is also a Collaborating Network Investigator with the Graphics, Animation and New Media (GRAND) NCE.

He served two terms as General Counsel to the American Association of University Professors (AAUP) from 1994-98. In 2011-12, he served as the President of the Association of American Law Schools. He also has an NPR show The Law of Rock and Roll.

**Claire Bond Potter** is Professor of History and a Director of the Humanities Action Lab at The New School for Public Engagement.

**Ellen Schrecker** is Professor of History Emerita at Yeshiva University. A leading expert on McCarthyism, her many publications on the subject include *Many Are the Crimes: McCarthyism in America* (1998), *The Age of McCarthyism: A Short History with Documents* (1994, rev. ed. 2002), and *No Ivory Tower: McCarthyism and the Universities* (1986). She also writes about higher education and, from 1998 to 2002, edited *Academe*, the AAUP's magazine. Her latest book is *The Lost Soul of Higher Education: Corporatization, the Assault on Academic Freedom and the End of the University* (2010). She is now looking at faculty politics in the 1960s and early 1970s.

**Jeffrey J. Williams's** most recent books include *The Critical Pulse: Thirty-Six Credos* by Contemporary Critics (Columbia UP, 2012) and *How to Be an Intellectual: Essays on Criticism, Culture, and the University* (Fordham UP, 2014).
